### MINNESOTA NO-COST COMMUNITY TESTING SITE IN CHISAGO COUNTY:

- Testing Type: Saliva (PCR) and Rapid (Antigen)
- Cost: Free

### COVID-19 TESTING THROUGH PHARMACIES:

- To schedule an appointment: Call 651-257-4074 Press option 4
- Testing Types: Nasal Swab (PCR)
- Cost: \$190.00; payment is collected when you book online. You may submit the invoice to your insurance company to attempt reimbursement. Your emailed invoice will contain the billing codes you will need.
- Results as fast as 40 minutes

  - Rapid Antigen for \$99.00
  - Rapid PCR Test for \$189.00
  - Rapid Antibody Test for \$50.00
- Payment is collected at the time of testing or when you book an appointment online. You may submit to your insurance company to attempt reimbursement, as your invoice will contain all the billing codes and information you need.

### COVID-19 TESTING THROUGH CLINICS:

**M-HEALTH FAIRVIEW CHISAGO CITY (11725 STINSON AVE CHISAGO CITY, MN 55013)**

- To schedule an appointment: 651-674-8353 (North Branch) 651-257-8499 (Chisago City)
- If people are having symptoms and they want to be tested for COVID then they can be seen in Urgent Care at the North Branch site and they will be tested. Otherwise if people want to be tested because they were exposed, they need to either call and leave a message for their doctor and then the doctor will more than likely place an order for the person to be tested and then the person will need to go to the office to get tested. They can also have an E-visit with their doctor and then get the order to be tested.

**ST. CROIX REGIONAL MEDICAL CENTER (235 E. STATE ST. ST. CROIX FALLS, WI 54024)**

- To schedule an appointment: Call 715-483-3221 to speak with a scheduler to setup your appointment. You will need either an in-person provider visit or CroixCares Virtual Health visit prior to being able to schedule a COVID-19 test.
- Cost: \$180, but many insurance companies have waived patient out of pocket cost. SCRMC is participating in a government program that may waive the cost for patient's without insurance.

### AT HOME TESTING OPTIONS:

BinaxNow at-home testing kits are available at Walgreens and CVS stores for in-store purchase for around \$24/kit
